Utah Mock Trials

Utah Law Related Education sponsors the mock trial competition which is open to all secondary schools in the state. Teams of up to 11 students argue a case, once as the plaintiff/prosecution and once as the defense. Teachers interested in sponsoring a team should contact the Utah LRE office at lre@icw.com.

We are so grateful to the hundreds of supporters who coached and judged the mock trial teams competing in the 2013 Mock Trial Program. Seventy-two teams competed in ninety-six playoff, quarter-final, semi-final, and championship mock trials. Most of these trials, lasting 3+ hours, were judged by a panel of two attorneys and one community representative. Together, more than 3,000 hours were donated.

The 2013 High School Championship teams were Woods Cross High School, 1st place, and West High School, 2nd place. West High 9th Grade placed 1st in the Junior High Division, with Centennial Junior, 2nd.

Woods Cross High School participated in the National Mock Trial Competition in Indianapolis, Indiana. With teacher Brook Gregg's support and dedication, the mock trial students placed 23rd nationally. Student-attorney McKay Holbrook received special recognition for his 5th place best-attorney performance in the competition.

On February 13, 2013, students from Alta High, Mountain Crest High, and Sky View High participated in the State Mock Congressional Hearings at the Utah State Bar Law and Justice Center. Sky View was the championship team and represented Utah at the National Competition in Washington, D. C.

The State Junior High School Competition was held February 7, 2013, at the Utah State Bar Law and Justice Center. Centennial, Central Davis, Eisenhower, Pleasant Grove, Rocky Mountain, and West Jordan junior high school/middle school students prepared responses to question two in each of the six units. Pleasant Grove Junior High School won first place, with West Jordan Middle, second, and Centennial, third. The 2014 Junior High School Competition will be held on February 13. Junior High School classes will prepare for question three in each of the six units.

In June, Tyler Bugden joined the Utah Law Related Education staff as the Director of Salt Lake Peer Court. After graduating from Tufts University in 2009, he returned to Salt Lake City to work as a Recovery Assistant at the Volunteers of America Adult Detoxification Center and as

an English instructor in the Salt Lake City School District. With a TEFL certificate and a year of teaching experience, Tyler moved to Quinto, Equador, where he taught international business English for six months. He spent the next six months in Argentina, Bolivia, and Peru before returning home to work part-time as an Internship Coordinator at the University of Utah's Lowell Bennion Community Center.

Salt Lake Peer Court

Salt Lake Peer Court is a prevention/intervention program utilized by the Salt Lake City School District and Juvenile Court. Approximately 325 youth are referred to Peer Court each year. Offenses most commonly referred are chronic truancy, fighting, disorderly conduct, theft, vandalism, harassment, and tobacco.

Salt Lake Peer Court is

- A three part program: 1) Court Hearings,
 2) Peer Mentoring, and 3) Mediation;
- An alternative to the traditional juvenile justice system and school disciplinary proceedings using a non-adversarial approach for youth who are sentenced and mentored by their peers;
- A restorative-justice approach to hold youth accountable for their actions, to build skills, and to strengthen their ties to school and community;
- An approach which empowers youth and communities to take an active role in addressing the early stages of youth delinquency; and
- A program that eliminates social barriers and unites youth throughout the community as they collaborate to intervene with referred youth.

Constitution Day

September 17 is recognized in the United States as Constitution Day and Citizenship Day. The purpose of this day is to commemorate the creation and signing of the supreme law of the land and to honor and celebrate the privileges and responsibilities of U.S. citizenship for both native-born and naturalized citizens. Federal law requires that all schools receiving federal funds hold an educational program for their students on September 17 of each year.
